POOL HOURS

Regular Hours 10:00AM – 7:00PM

Swimmers must leave the pool deck by 7:00PM

Pool hours are subject to changing – closing time subject to sunset and weather conditions.

CHILDREN'S HOURS Saturday until June 29th (SETTLERS POOL ONLY) 11:00AM – 2:00PM CHILDREN'S HOURS Starting July 1, 2024

Monday, Tuesday, Friday, and Saturday

Children may not enter the pool deck any earlier than **11:00AM**. Children must leave the pool by **2:00PM** and vacate the pool area. **NO ALCOHOL & NO DIVING**

Everyone must be out of the pool and the deck must be cleared at closing time. Outdoor bathing is prohibited during an electrical storm.

SWIMMING POOL RULES and REGULATIONS 2024

There are two swimming pools in LeisureTowne at Laurel Hall and Settlers Hall. All residents and their guests, including children, using the pool facilities do so at their own risk. The LeisureTowne Association is not and will not be responsible for any accidents in connection with such use.

Eligibility

All LeisureTowne residents in good standing and their invited guests are eligible to use the pools with the following restrictions:

- 1. Guests may use a pool ONLY when accompanied by a resident. Residents must remain with their guests.
- 2. Only residents and guests fourteen (14) years and older are permitted within the pool gates, except during the hours specified for children.
- 3. Only children three (3) years of age or older, who are **completely toilet-trained**, are permitted in the pool or within the white line on the pool apron.
- 4. Cloth or disposable diapers are not permitted in the pool for either child or adult.
- 5. An adult must accompany a non-swimming child or any child under the age of seven in the water.
- 6. While the whirlpool at Laurel Hall is in operation, no one under sixteen (16) years of age is permitted in the whirlpool.
- 7. Children under 3 are not permitted within the white line on the pool apron.

Admittance to the pool

- 1. Every resident has access to the pool with a LeisureTowne Swipe card (You must swipe in and out with your own card)
- 2. Up to four (4) guests are permitted per household. LT Resident must sign their guests in on the guest sign in sheet.

Use of the Pool - NJ State Sanitary Code Chapter IX requirements are listed in bold.

- 1. Any person with excessive sunburn, open blisters, cuts, or bandages shall be denied admission.
- 2. Do not enter the water if you are experiencing or recovering from diarrhea or have had any signs or symptoms of gastrointestinal (stomach) disease in the past seven days.
- 3. Children should be encouraged to use the restroom before entering the water. Immediately report any "accidents" you observe in the bathing waters to the pool monitor.
- 4. Cloth or disposable diapers are not permitted in the pool.
- 5. No animals shall be allowed in the swimming pool or whirlpool.
- 6. Glass containers shall be prohibited.
- 7. Conduct which endangers the safety and comfort of others shall be prohibited.
- 8. Outdoor bathing shall be prohibited during an electrical storm.
- 9. Persons suspected of being under the influence of drugs or alcohol shall be prohibited from entering the water.
- 10. Any person showing evidence of any communicable skin disease, sore or inflamed eyes, cold, nasal or ear discharges, or any other communicable disease shall be denied admission.
- 11. All persons must shower before entering the water.
- 12. EVERYONE must wear exercise shoes in the pool during exercise classes or any ball playing games.
- 13. Residents are obligated to actively supervise invited guests in and around the pool. Special attention must be given to children.
- 14. All injuries must be reported to the POOL MONITOR.
- 16. Only proper swimming attire is acceptable for the pool and no cutoffs are permitted.
- 17. All persons wearing bathing suits and wishing to use the club house facilities must use the marked entrance/exits for showers and restrooms. Children must be accompanied by an adult when using these facilities. *All persons must wear shoes when entering any building*.
- 18. Light snack type foods such as fruit or individual snack size containers are permitted. The pool deck is a "carry in, carry out" trash area. Sandwiches and dinner type foods must be eaten at the designated picnic areas. Gum chewing is not permitted in the pool area. Glass containers of any kind are prohibited.

19. No alcohol is permitted; Violators will lose privileges for 30 days.

- 20. No running, playing tag, rough and rowdy play, cannon balling, water pistols, guns, or other squirting devices, or blaring radios will be permitted in the pool or on the pool decks.
- 21. Ball playing is limited to a designated area only between the hours of 3:00 PM and 5:00 PM and permitted only if the pools are not crowded as determined by the pool monitor for both Laurel and Settlers pools.
- 22. Pool noodles and pool noodle chairs are permitted. Rafts are **not** permitted in the pools.
- 23. If you use this amenity, it is at your own risk of exposure to COVID and other communicable viruses and diseases. By using the amenities, you agree to take all responsibility for your own health.
- 24. The Association makes no assurance regarding the cleanliness and sanitation of the facilities.
- 25. All Persons Should Shower before entering the pool.

Responsibility

- 1. All residents and their guests, including children, using the pool facilities do so at their own risk. The Association is not and will not be responsible for any accidents in connection with such use.
- 2. Members and/or guests will be responsible for the cost of any damages caused through their negligence and/or carelessness.
- 3. The Association is not and will not be responsible for loss of jewelry, valuables, clothing, or property in or about the pool.
- 4. No chairs, tables or lounges can be reserved. Every resident has an equal right to their use. When the pool deck is crowded, personal belongings must be removed from extra chairs to allow others to use these chairs.
- 5. No smoking, No Vaping is permitted in the pool, on the pool deck, or at the entrance apron to the pool deck or in the Clubhouse.
- 6. **No Diving or jumping into the pool is permitted.**

Children's use of pool - age 13 and younger - SETTLERS POOL ONLY - Monday Tuesday, Friday, and Saturday

- 1. Children 13 years or younger are only allowed in the pool area from 11:00 AM 2:00 PM.
- 2. Only children who are three (3) years of age or older and who are completely toilet trained are permitted in the pool, or within the white line on the pool apron. Children wearing cloth or disposable diapers are not permitted in the pool.
- 3. An adult must accompany a non-swimming child or any child under the age of seven (7) in the water.
- 4. No one under sixteen (16) years of age is allowed in Laurel Hall Whirlpool.
- 5. Children's swimming ability will be evaluated before they are permitted to swim in the deep end of the pool. NO EXCEPTIONS. Wrist bands denoting the ability to swim at the deep end are issued. Wrist Bands must be worn while in the pool area.

Laurel Hall Whirlpool Rules (No one under 16 Years

- 1. **Persons using the whirlpool must be 16 years of age.**
- 2. Person using the whirlpool must not have any open wounds.
- 3. Person using the whirlpool must limit each time spent to 30 minutes.
- 4.. Only four (4) people at a time in the whirlpool
- 5. Only a pool supervisor can adjust the whirlpool settings.
- 6. The whirlpool will remain running 24 hrs. a day.
- 7. Any person with heart diseases, diabetes, high blood pressure or those using prescription medication should not enter the whirlpool without prior medical consultation and permission from their doctor.
- 8. Do not use the whirlpool while under the influence of alcohol.

THESE RULES HAVE BEEN ESTABLISHED ON THE BASIS OF THE STATE OF NEW JERSEY SANITARY CODE CHAPTER IX FOR PUBLIC RECREATIONAL BATHING AND ON PAST EXPERIENCE AND HAVE BEEN DESIGNED FOR THE COMMON GOOD OF RESIDENTS AND THEIR GUESTS. EVERY RESIDENT SHOULD BE FAMILIAR WITH AND ABIDE BY THESE RULES. ANY RESIDENT OR GUEST WHO VIOLATES THESE RULES FORFEITS HIS OR HER RIGHT TO REMAIN IN THE POOL AREA. LACK OF COOPERATION WILL RESULT IN THE POOL BEING CLOSED UNTIL THE VIOLATORS LEAVE THE POOL AREA. THE LIFEGUARD MAKES THE FINAL DETERMINATION ON ALL SAFETY ISSUES.
